The primary objectives and purposes of Greyhound Pets of America Greater Northwest (GPAGNW) shall be to find responsible loving homes for greyhounds which fail to qualify (or no longer qualify) for the racetrack, to acquaint the public with the desirability of greyhounds as pets, and to inform the public of the availability and “pet-ability” of greyhounds for adoption.

GPAGNW is focused on the welfare of the greyhound, we are not animal activists or an animal rights group. However, GPAGNW will take immediate and appropriate action if we are made aware of any greyhound being mistreated or abused. As an organization we do not lobby, march, or picket against anything – as we consider these activities be counter-productive to our stated purposes. GPAGNW is politically neutral and is neither pro nor anti-racing. Volunteers agree to support these statements.

Any funds collected for GPAGNW shall be given to the area vice-president. All GPAGNW property used by the volunteer remains the property of GPAGNW and shall be returned upon volunteer termination.

A volunteer in good standing is one who has been active for at least a year. These volunteers are voting members and are eligible to vote for their area board member(s). Volunteers agree to abide by the stated policies of GPA National and Greyhound Pets of America Greater Northwest.

GPAGNW volunteers agree to promote the positive aspects of this organization and not discuss or share their opinions about any other group. If someone asks about another group, a good response might be, “I don’t know anything about them, but let me tell you about us.”

GPAGNW volunteers agree to represent this organization exclusively.

I hereby agree to release Greyhound Pets of America Greater Northwest from any liabilities resulting from any action or inaction on my part or action or inaction on the part of Greyhound Pets of America Greater Northwest.
